Audit for State of Oregon will cost 29,000 because of federal and state regulations. Will pursue pricing with area CPA's for budget purposes.

**Engineering Report:** All of town is done as far as main line. No laterals yet.

Mini Lift stations are cheaper and we will have 4 lift stations for industrial will be FS responsibility. They will be utilized from their current building.

Manhole integrity is being grouted and testing. Next will require pressure tests on main line ODOT will allow us to do gravity alone on OZMAR.

**Project Managers Report:** Rates are still being determined. A discussion will be started at next meeting in July 8, 2020.
