### **President's Report**

Kim received an email that confirmed that CSD would receive \$835,000 for the Crescent Sanitary District infrastructure project. CSD is still unsure what that money can and cannot be used for.

Petitions were mailed out for the Gilchrist annexation. CSD is still waiting for replies in order to receive the necessary signatures in order to annex Gilchrist.

CSD needs someone who can sign off on CSD's monthly sewer reports who has wastewater treatment operator I. Clint Whitney of Oakridge is an operator who has this certification and is willing to sign CSD's DMRs at a price of \$600 a month or \$2 an EDU, whichever is greater.

Chuck Lawrence and Scott DeCarlo discussed the importance and necessity of routine maintenance on the sewer system and the importance of acquiring a pump truck in order to conduct said routine maintenance. They discussed whether pumice damaging the pump is covered under warranty or if the cost of replacing a pump that was damaged would fall to CSD.

CSD discussed changing the rates for Motels, Hotels, and RV parks. CSD also discussed the RV dump fees and the effect of dumping on the bacteria in the ponds.
